Segment #1: Enter the Dragon “Asking-Hands” Face Off Comparison

1st decisive Hand-Strike scores / Best 2-out-of-3 wins / Right & Left Leads will be compared / Head & body contact are counted / No kicks are allowed until after the initial hand strike is attempted / No points for kicks, only as restarts. Any prolonged detachment will result in restarts. NO “Game of Tag” will be played here and no minimal contact is counted, all strikes counted should have reasonable impact. Protective head gear, lightweight MMA gloves, mouth, groin & shin guards are required.

Segment #2: Fists of Fury “Stand-up” Comparison of Kicks & Punches

2-Two minute Rounds / 1-One minute final Round if undecided. Takedowns are allowed but no follow-ups to the ground will be allowed. No points for Takedowns, only restarts. Clinches are allowed with Knees to the abdomen, but no Elbows strikes to the head. Protective head gear, Boxing gloves, abdomen protector, shin guards, mouth, groin & shin guards are required.

Segment #3: “Go-with-the-Flow” Grappling Comparison

1-Five minute Round / 1st undisputed Submission wins / 1st controlled Takedown in final round if undecided. Protective mouth & groin guard is required.

***Remember to bring water, a towel, specified protective gear, and completed Registration forms & fees.**

***Registrants are expected to be courteous to fellow Participants or be removed without a refund.**

International JKD Comparison 2017

“Official Rules and Regulations”

1. Segment One: Enter the Dragon “Asking-Hands” Comparison

- A) With lead hands in a crossed position, match begins only when Referee announces a “START” to commence.
- B) First face-off is conducted from a right lead stance. Second from a left lead. The Third again from a right lead.
- C) Participants may only use “Entering into Trapping into Punching” for their initial attack.
- D) The first decisive hand strike to connect wins each face-off. Participants **MUST immediately discontinue** all contact whenever a Referee calls out “STOP” during a face-off.
- E) Prolonged contact detachment will constitute an immediate stoppage and a restart will occur from same position.
- F) Kicks are allowed only after initial hand-strikes, but receive No Points. Kicks may be used to restart the face-off.
- G) Best 2-out-3 wins this Segment and moves on to the next Segment.
- H) The emphasis will be based on effective (SDA / ABC / HIA / PIA) speed & power of techniques in Trapping-Range.

2. Segment Two: Fists of Fury “Stand-Up” Comparison of Kicks & Punches

- A) This segment will follow similar guidelines as seen in most regulated Kickboxing matches. No Elbow strikes to the head will be allowed whatsoever. Knees are allowed to the body only from a clinch or momentary tie-up. This Segment consists of two 2-Minute Rounds or until a TKO or KO occurs. Points will be counted if no TKO / KO have occurred. A final 1-Minute Round will commence only if there is no clear Winner in the prior rounds.

3. Segment Three: All Tap Out “Go-with-the-Flow” Grappling Comparison

- A) Most forms of Grappling & Submissions are allowed in this Segment. Participants will begin from a standing face-off position. Everything from Judo, Sambo, Jujitsu, BJJ / Jiu-jitsu & “Catch-as-Can” Wrestling is permitted. Duration of Round #1 will be 5-Minutes. 1st decisive Submission will determine the Winner. An additional Round will commence only if there was no clear Winner of the initial round. 1st Takedown will end the 2nd Round.
- *ANY intentional violent contact made will result in immediate Disqualification without any refund due. (NO eye, throat, knee or groin attacks, NO gouging nor ripping of flesh, & NO uncontrolled joint-locks are to be permitted.)*
 - *ANY incidental contact made will be considered by the Referee & Judges as accidental if cause is apparent.*
 - *All participants **MUST** obey the rules & regulations as set forth in this document or withdraw themselves thereof.*
 - *Coaching is allowed prior to a face-off, but NO further interference is allowed once each face-off begins.*
 - *All Participants **MUST** provide their own approved Protective Gear, including a Mouth Guard, full Head Gear, Shin Guards, Groin Protector (Males) Boxing Gloves and lightweight (Open-Fingered) Gloves.*
